# The True Nature of a Human Being

### A. What needs to be known and understood about the Human Being:

The knowledge of the True Nature of a Human Being is an unbelievably missing science or technology. Although this True Nature is almost diametrically opposite to the teachings of the academic knowledge, when looking at the vast amount of *EMPIRICAL* observation and 'others' findings it may be better envisioned as a *TRUTH*.

As a brief summary, a Human Beings *NATIVE STATE* is one of containing all of the *PRO SURVIVAL* Characteristics of the *SPIRITUAL* Component of the '*I*' as outlined throughout 'SR' *DOCUMENTATION*.

### Some Human Nature Basics of the 'SR' Foundation

### **B.** The Rudimentary Basics:

The human Being consists of two diametrically opposed entities. One of the components of the human being is the physical body, the other is their *SPIRIT* or *SPIRITUAL* component. The human beings body is a carbon oxygen machine with a control mechanism referred to as the Stimulus Response Mechanism (*SRM*).

Within that context it is identical to that of an animal, although the Human Body is only one variety of the multitude of bodies existing on the planet, its operational parameters are the same or similar in basics of the Stimulus Response Mechanism (*SRM*).

Science has expended an enormous amount of concentration in studying not only the human body but animals as well, not to mention the study of vegetation that exist on the planet. An enormous amount of wonderful data and technology has arisen out of those scientific studies and conclusions. Unfortunately science has done very little (if anything worthwhile) to investigate and *UNDERSTAND* human behavior, character and *THOUGHT*. Any science (in the mainstream) has been based upon the idea that the only difference between the Human being and an animal is that the human being has a larger brain. It may be true that the human being has a large brain, but is the large brain responsible for the human characteristics or are the human characteristics responsible for their large brain?

The human characteristics such as: being aware of being aware, *COMPASSION*, egalitarianism, consciousness of life, ability to evaluate and reason are not to be found in any animal. By far the greatest number of these perceived abilities in animals can be traced to the Stimulus Response

Mechanism (*SRM*) of the physical body's pursuit of survival through protection, food and procreation through survival of the fittest. This has been quite accurately discovered and pursued by science and is the mechanism of the GE. Within all animals (and vegetation) the GE is *RESPONSIBLE* for the learning and passing on to the next generation all Stimulus Response Mechanisms (*SRM*) that are required to adapt to new environments and greater survival potential. That is the evolution of a species whether Vegetation or Animal, human or not. Another vital component that may and does have a profound influence on the structure of the GE in a human beings ability to learn from the exposure of the environment created by other human beings and to a major contributor their ability to learn or develop '*OPINIONS*' through education and indoctrination

In *SIMPLICITY*, the Human Being possesses what may be called the '*DEVELOPED EGO*' or '*SOCIAL VENEER*' (see drawing on P196 "Components of the Human Being" in "An Overview of 'SR') that is part of the brain of the physical body and what may be called the '*NATIVE EGO*' (see drawing on P196 "Components of the Human Being" in "An Overview of 'SR') that is part of the *SPIRITUAL* component of the human being, not being part of the physical body. See Page (196) in the Exposition "An Overview of 'SR'". The '*NATIVE EGO*' has a closer connection to the Human Beings native state of *GOODNESS* or the "*I*" although it may <u>develop</u> to contain a greater influence from the experiences and data received from the human body or the Stimulus Response Mechanism (*SRM*).

Two vital components now can shape the state of the 'NATIVE EGO'. The first is the true nature of the SPIRITUAL component or the "I" and the second is the pressures exerted by the Stimulus Response Mechanism or brain of the human body. When these pressures of the educational and indoctrinational environment, that oppose or contradict the SPIRITUAL components or the "I", are greater than the influence of the II, the less the individual will develop to represent the true nature of the Human Being. Within the Human SPIRIT the "I" is a constant that does not get influenced or altered by any association with the human body as does the 'NATIVE EGO'. If the pressures from the body are greater on the 'NATIVE EGO' than the influence of the "I", the *NAIVE EGO* will more and more deteriorate with the resultant effects on the offspring through the attachment of the "I" to the body (see drawing on P214 "Evolution and Progression of the 'I' or SPIRIT" in "An Overview of 'SR'). Furthermore this deterioration of the NATIVE EGO also has an effect on the development of the GE. This in essence is the deterioration of a society, not in a material sense but in a SPIRITUAL sense. This deterioration ranging from the deterioration of the NATIVE EGO to the deterioration of the DEVELOPED EGO of the human body and the resultant influences on the GE is what may be and is conceived to be that the Human being is 'evil' at birth and must be taught to be GOOD.

# C. The *PHILOSOPHY* of *LOVE* Poem:

- 1. In order for an individual to get the full and true concept expressed in the Poem "The *PHILOSOPHY* of *LOVE*" the words '*INTUITIVE*', *PAIN*' and the word '*LOVE*' must be understood in the full 'SR' context. These words are expressed within the full awareness of and practice thereof, the second component of the Human Being, the *SPIRITUAL* component or the '*I*'.
- 2. Within the true understanding of the Human Beings True Spiritual nature this poem reveals the whole range of Human beings degradation from their true nature.
- 3. It covers the whole range of *NEGATIVITIES* from dislike, through to *BLAME*, anger, hate, *RETRIBUTION*, punishment, Human beings condemnation, up to the concept of war.
- 4. If there is or was ever an individual who is operating only on their true native state of their *SPIRITUAL* capacity and is ever discredited or invalidated for their state, the individual starts the slide towards more *NEGATIVE* characteristics.
- 5. Thus we have the full range from dislike to war that is essentially created by the invalidation and degradation of the True Nature of a Human Being and anything that causes an *INTUITIVE PAIN* in any individual.
- 6. There is no indication here that even if something like ten percent of the planets population would have the wisdom of this fact in *UNDERSTANDING* and practice, that wars, or any other of the *NEGATIVE* attributes of human interactions, on the planet would be eliminated.
- 7. No, the understanding and application of the True Nature of a Human Being must grow at the highest possible rate through something that will give individuals hope that the deterioration of the human race can be halted and reversed.

### **D.** The Concept of War:

Within the concept of application, the concept of war has always had a rather insane presumption, which in simplicity could be summarized in - "Let us fight a war to end all wars". A more sophisticated view would be that we have to fight and eliminate the opponent by some sort of force. With the true understanding of the nature of a human being it can however be seen that all need for retribution, blame, punishment, war and any such 'inhumane' actions or thought have been the cause for the existence of such 'inhumane' actions. Most likely one or the current societies doctrines that have propelled such misunderstanding is the research done by Sigmund Freud who claimed that humanity is evil by nature and needs to be educated or 'indoctrinated' to be good. It may be well understood, that he however, in the turbulent and cruel environment that he lived in, it was an easy conclusion to come by. Not only that but that it was a very convenient doctrine that was very useful to the *MONEY MANAGERS* who wished to control human beings not for the benefit of the human beings but their own ambitions. It is however a lengthy disclosure, too long for this short dissertation but the true facts are as follows: An individual by their native characteristic of being a spiritual being inhabiting (or not) a body (See Page 213

"Evolution and Progression of the Spirit and Body" in "An Overview of 'SR'.) is not capable of any such evil characteristics that need to be punished. It is also true that at birth of a new body and the association with that body of the being, that being has been throughout history controlled, enslaved, indoctrinated and misused. It is this cumulative imposition of oppression which is responsible for the appearance that at birth a human being is evil, or at least a incompassionate or indifferent individual. It would be quite safe to state that through recognition, time and effort, if any such spiritual degradations be it from parents, environment or individual bent on controlling others and treating them as animals turning them into a strife for survival of the fittest, without understanding their spiritual nature, wars, retributions, punishments and the likes could not disappear.

### E. Items of VALUE:

Like so may other things, there are really only two possibilities to everything. Such it is with items of value. One is items such as land, air, water, vegetation, animals and generally all matter on the planet. The other is productive efforts of a human being. The productive efforts of a human being belong to that human being. Everything else belongs to the planet which is there for the use of all life on the planet including the planet itself.

# F. RESPONSIBILITY:

It is the individuals *RESPONSIBILITY* to participate, even lead, in creating better societies that will build a better world. Although the individuals within the society are as indoctrinated to strive for the same ends that the governments (selected from the individuals within that society) is indoctrinated. This end is to ensure that nothing is done to destabilize the indoctrinated 'economic' METHODOLOGY implemented within that society. Thus it may be a greater REALITY to DISSEMINATE to individuals who hopefully then co-ordinate their efforts instead of every group pursuing their individual agendas. In the current state of affairs (as implemented by the MONEY MANAGERS) it is after all the INDIVIDUAL who demands from the Government the continuance and enhancement of the 'economy' that is RESPONSIBLE for the exponentially widening gap between the 'Haves' and 'Have nots'. The indoctrinated concept furthered by the people, governments and enforced by the MONEY MANAGERS is that the only and true happiness that the individual can attain is the increased possession of material goods. And it is lost to all, that this true happiness is no more than a sham while the FACT is that true happiness is attained by having the knowledge and application of the characteristics of the components of the two diametrically opposed components of a Human being their physical body and their SPIRITUAL components or the 'I'

One of the most difficult things that most individuals will encounter about the concept of *RESPONSIBILITY* is as follows:

Looking at some of the ills and deterioration existing on the planet it must be quite apparent that it is not the Government, Corporations or Organizations that are *RESPONSIBLE* for these ills. All of the listed entities do not have "*SUSTAINABLE* Social *ECONOMIC* Well being" as any part of their agendas. Whether it is not in their mandate or they have been indoctrinated to follow a different agenda is not of relevance. What is, is that all existing entities have on their agenda the improvement of the 'economy'. In *SIMPLICITY* it is that all entities wish (or are indoctrinated) to ensure that the 'economy' is successful if the individual within that society has a good job, makes money, and then spends that money on increasing their affluence. Thus it is self evident that if the individual (collectively) would reduce their demands and acquisitions of goods

by X percent, the ills created by the entities indoctrinating the populace to follow this path would be reduced by X percent.

This is where it can be seen that the ultimate *RESPONSIBILITY* for the ills on the planet has to be carried by the individual, individually and collectively.

### G. Neuroplacticity:

As current scientific discoveries are finding out about the neuroplasticity of the brain it is said that the individual has to recognize these discoveries and work towards making these discoveries a reality. It is only those few individuals who have the capacity to understand the true nature and composition of the human being and comprehend that the human being consists of two diametrically opposed entities who have a chance of truly being able to work with these discoveries. These two components of the human being are their physical body and their spiritual (not to be confused with religious) component that would correctly be described as the "*I*". After all if the human being is nothing more than a body and brain, who or what is it that can control or alter the structure of the brain, is it the brain or is it the only entity that can not only alter the brain but all aspects of the human body. It is however to be understood that this by no means is to discredit the very valid and valuable sciences of thing such as genetics, the environment, education and others.

### H. Two Quotes:

In an interview on the 'Axe Files' with John Kerry, Kerry makes a statement to the effect of "do not let education interfere with your knowledge". In concept similar to Albert Einstein's alleged statement "The only knowledge I have left is the knowledge I have left after I have forgotten everything that I have learnt in school.

### Awareness:

### I. About Awareness and Action

Awareness of the way things exist on our planet must be *DISSEMINATED* and created. It should also be realized that awareness and action are only related and are not mutually inclusive.

When an individual becomes aware of something that is not right, the individual should consider that this awareness is not necessarily a requirement for action or implementation. At least not if the awareness of the not right creates an emotion that the individual has to act upon the thing that they have become aware of.

If the awareness of the situation causes the individual to desire to act as opposed to a feeling that the awareness causes them to have to act, it is not only desirable but creates a feeling of contentment and happiness within the individual.

The most important element of the individual collectively is the knowledge and understanding of the fact that the human being is one half a body and one half a spiritual being or the '*T*'. Only when that is accomplished can the individual work on becoming more a spiritual being (than body) and work on that understanding, thus creating an environment for themselves and others where true contentment can be developed and exist.

The most important thing for every individual is to gain awareness of the fact that the indoctrination, that is disseminated, that happiness lies in the maximization of money and material things, is a complete scam, and instead lies in the harmony, association and caring for others, nature and the universe which is the one part of a human beings spirituality or 'T'. (See the

PDF file "The Politics of meaning" on Page "Non 'SR' Material/ Other Sites/Michael Lerner. If it would be possible to fully and accurately cause the individual to be in complete harmony with their spiritual nature the '*I*', the False 'economy' would inherently evaporate and structure itself along 'SR' parameters without having to be *DISSEMINATED*.

None the less, in current environments it is just as important to understand the principles of the existing 'economy' as well as the solutions to this 'economy' at the same time as to gain a relationship with the True Nature of the Human Being.

It is not that the understanding of the 'economy' is primary to the understanding of the true nature of a Human being, or visa versa. Both aspects of the Root Cause need to be understood in conjunction.

#### Some basic Foundations of the 'SR' Technology

#### J. One of the most vital foundations of the 'SR' Technology.

This foundation has to be understood and recognized as a priority at the onset of study of the makeup of the 'SR' Technology. The aim of the Technology is to create and grow a theoretical APPLIED Technology that promises to build a society where "*SUSTAINABLE* SOCIAL *ECONOMIC* WELL BEING" is the basis for the entirety of its operational doctrine, rules, regulations and structure. "*SUSTAINABLE* SOCIAL *EONOMIC* WELL BEING" of course can only be achieved when it accomplishes the recognition of and application of the concept that an individual can only maximise their benefit and survival when the interdependence of everything within a society they live in (as well as the global society and the environment) is recognized as a benefit. Therefore it becomes self evident that the vital nature of achieving this "*SUSTAINABLE* SOCIAL *ECONOMIC* WELL BEING" must demonstrate its *INTENT* through one hundred percent *TRANSPARENCY* of the entity wishing to attain it.

Within the majority of currently existing planetary societies, where "INDIVIDUAL ECONOMIC WELL BEING" is omnipresent and the lone individual is the norm, there is a *PAINFUL* recognition. In basics it is that a clear *UNDERSTANDING* of the difference between *DISADVANTAGE* and *HARM* has to exist. A great deal of emphasis is placed in the 'SR' Technology that all of the proposed bylaws eliminate *HARM* to anyone, or for that matter anything while accepting a *DISADVANTAGE* to anyone or anything that is a benefit to another or the collective.

The *PAINFUL* recognition mentioned above is frustrated in that this lone individual is usually more interested in their own and current well being without much (if any) concern for others, nor the planets resources. This being the norm will tend to make that lone individual not want to take any *DSADVANTAGE* of their short term benefit which however will dramatically decrease their long term or *SUSTAINABLE* well being in the future. Although this is a very destructive consequence to achieving "*SUSTAINABLE* SOCIAL *ECONOM*IC WELL BEING" the concept of implementing recognition that an individual can only maximise their benefit and survival when the interdependence of everything within a society they live in is recognized as a benefit to their and everyone's long term affluence has to remain one of the most vital foundation of the 'SR' Technology.

As a summary and conclusion of the above is that since the aims of the 'SR' Technology is to build a "*SUSTAINABLE* SOCIAL *ECONOMIC* WELL BEING" society, any bylaw, rule or regulation is designed to accomplish this aim. If there is such a bylaw that does not conform to this aim, indeed it needs to be exposed and corrected. If found that that bylaw is supportive of the aims, there is no *JUSTIFICATION* for anyone to claim human *RIGHTS*, or any *RIGHT* of a human being, to their *VESTED INTEREST* that is at the expense of anyone or anything else.

### K. The entry knowledge to the 'SR' Technology

To those few who may see and understand the rudimentary discussion on the previous page "'SR' Manifest", two aspects of the "ROOT CAUSE" of the social decline collectively, it may seem very hopeless and somewhat depressing. And indeed it may be. However when looking at some of the other realities it may take on a somewhat more positive hope. Although it may be true that the ultimate power of control and influence in current societies are the 'MONEY MANAGERS' and indeed all individuals from the common individual to the Government who support the improvement of the 'economy' one thing can be visualized:

Let us first assume the following, based upon the largest portion of past civilizations. The ultimate power and control of any society is by its leaders or the Government. This appears evident, but it must also be realized that this ultimate power of the Government exists only as long as that government has the support of the people collectively. If not instantaneous, the erosion of this support by the people will eventually lead to the societies collapse with the resultant chaos and hardships for the people. And what is it that erodes the peoples support of the Government? In SIMPLICITY, as has been alluded to in the discussion of the Human Being on the previous webpage "SR' Manifest"; is their discovery that that Government does not work for the benefit of the people. Next, it has to be understood that in most societies, where the government is "elected by the people" their power to do anything for the benefit of the people which may be at the expense of the "MONEY MANAGERS" is easily corrected by making sure that the next elected government is again concerned with the improvement of the 'economy' for the benefit of the 'MONEY MANAGERS'. Lastly it is recognized that as opposed to the Government, the 'MONEY MANAGERS' with their families, supporters and indeed the collective INDIVIDUALS remain in control, literally for centuries. If there is anything that the 'MONEY MANAGERS' object to (that they have missed in their support of the current Government) they have little problem, if any, to reverse the trend back to their benefit at the next election.

Theoretically then, what would be required for a Government to overcome this conundrum? A sample letter that may give an overview of why it is and what is required that the 'SR' Technology can and must be implemented by a societies government. This letter can be found on Page 230 of the *DOCUMENT* "E02 An Overview of 'SR'".

First, the individuals in Governments would need to have a *REALITY* that the true nature of a human being is of *GOODNESS* instead of evil that needs to be controlled and enforced by punitive actions, laws and *RETRIBUTION* with the *INTENT* of forcing them to be good and behave. The realization that these punitive actions do the exact opposite of what they are claimed to do and drive the true nature of a human being into a state of the 'lone individual' (See Page 150 "Characteristic scale of Vested Interest" on the webpage "An Overview of 'SR'") only concerned with their own well being, blaming everything else on someone or something else. The second requirement would be that there is a collective (non partisan) realization that under

the existing model of the 'economy' nothing can be done to create any society capable of pursuing "*SUSTAINABLE* SOCIAL *ECONOMIC* WELL BEING". Within the discussion above it can be realized that the need for full bi-partisan support of all political entities or at least the majority is a vital component. The third requirement would be to create something that does not require anyone or any entity to change their operating basis but create something new that can verifiably and fully *TRANSPARENTLY* demonstrate to individuals that this new thing is built upon *SUSTAINABILITY* for the benefit of all individuals individually and collectively. The fourth requirement would then be to pass some non-interference laws that prevent *VESTED INTEREST* entities (like the *MONEY MANAGERS* and their associates) from using their power and influence to discredit or destroy this new thing. Within all of that it would be up to the people collectively in the society to determine the fate of this new thing, as opposed to *VESTED INTEREST* individuals, groups, and indeed the populace.

It is acknowledged within the 'SR' Technology that in order for the Government of a society to become aware of the benefits of 'SR' (or equivalent) it would need to be addressed by various means not part of the 'SR' Technology. These means may include items such as *DISSEMINATION*, Activism, community building and may or may not include the data presented by the 'SR' Technology. See webpage "Home/Start here/'SR' Material/INVOCATION"

### L. Combining the two components of the Root Cause.

- 1. With the above brief outline of the two components of the 'Root Cause' it is now possible to aim for the understanding of the 'Root Cause' being the interrelation between the two components.
- 2. The power and influence that the *MONEY MANAGERS* have is what determines the nature of a society and the characteristics of its 'economy'.
- 3. Throughout History, whoever these *MONEY MANAGERS* were, they were able to structure the environment where the masses had to produce, not only for themselves, but the well being and affluence of the masters (The *MONEY MANAGERS*), who lived in superfluous affluence while the masses lived a wretched existence.
- 4. The more this gap increased between the wretched masses and the few in superfluous affluence the more unhappy and disillusioned the wretched masses became.
- 5. No matter how *MANIPULATIVE* and forceful the masters were, the human being will always have a certain connection with their true nature of *GOODNESS* and independence.
- 6. At some point in this discrepancy the society decayed or in most cases disappeared.
- 7. It has never been possible in history to destroy the true nature of a human being by force, *MANIPULATION*, slavery, or any other means.
- 8. It has been said that 'the most *PRODUCTIVE* slave is the slave who thinks they are free'.
- 9. This too, the MONEY MANAGERS have learnt over the centuries.
- 10. Another thing they learnt was that the closer the human being is in touch with their true *SPIRITUAL* nature, the harder it is to manipulate them to give up the fruits of their labors to them the *MONEY MANAGERS* as well as to every *INDIVIDUAL* willing to live off the backs of others.
- 11. Thus the *MONEY MANAGERS* developed methods and indoctrinations to convince the masses that their desires should fit the 'Stimulus Response Mechanism' (*SRM*) of the physical body, robbing them of the concepts of their true nature of the human being.

- 12. The *MONEY MANAGERS* recognized that the more individuals live in, and perceive that happiness through material possessions is primary, the more *WEALTH* and power they, the *MONEY MANAGERS* can accumulate
- 13. The larger the populations in a society, the more *WEALTH* can be collected by the *MONEY MANAGERS*.
- 14. Thus it is that a huge effort is made not only by the *MONEY MANAGERS* but by 99.999 etc. percent of individuals from the common *CITIZEN* to the highest official (or greatest *WEALTH*) consider that this model of the 'economy' is the most desirable for society (or rather for themselves.)
- 15. The huge effort made by the *MONEY MANAGERS* to indoctrinate and condition the masses is not only by them directly, but by their ownership and/or influence of institutions like corporations, media, educational institutions, associations, governments etc.
- 16. In short, the 99.999 etc. percent mentioned above, have been indoctrinated to fully support the desires of the *MONEY MANAGERS* and fight for the ever expanding principles contained in 'economy'.
- 17. Is it therefore not to be expected that the *INDIVIDUALS*, who have the most to gain by this system would work or show any interest in forfeiting their gain for the benefit of (the other) *INDIVIDUAL* in the society be it individually or collectively.

# The 'SR' Technology:

# M. The 'SR' entity:

First and foremost, several items should be listed about the 'SR' entity and its operation. It could be summarised that its only *INTENT* is to maximise the survival potential, *CONTENTMENT* and well being of human beings collectively on this planet. Its total operation is based upon the following baseline requirements and implementation.

- 1. Its only purpose is to supply goods and/or services <u>needed</u> by society.
- 2. It is designed to give any and all individuals who are part of, or aware of, the existence of an 'SR' entity, that that entity can be relied upon to be one hundred percent dedicated to giving those individuals as well as all *INDIVIDUALS* on the planet the benefits that they all deserve.
- 3. It is a theoretical, practical applied technology that has the capacity to convert the current paradigm of "*INDIVIDUAL* ECONOMIC DOMINANCE" TO "*SUSTAINABLE* SOCIAL *ECONOMIC* WELL BEING"
- 4. It is solely built upon the inherent *RIGHT* of every individual to be free of coercion.
- 5. It is also built upon the inherent *RIGHT* of every *INDIVIDUAL* to practice and defend any *THOUGHT* or action that is in cohesion with the characteristics of the true nature of the human being.
- 6. In creating the 'SR' Technology, a great deal of effort has been placed on insuring that all of the 'SR' directives contain and are derived solely out of parameters representing and based upon 'Human *RIGHTS'*. Included in this effort is the search for distinguishing between a 'Human *RIGHT'* and the much destructive right that "I have a right to pursue any initiative that in my *OPINION* is a desirable."
- 7. One of the most important consideration of 'SR' is *SUSTAINABILITY* of life on this planet

- 8. A further yardstick and consideration is one hundred percent *TRANSPARENCY* of all of its activities.
- 9. All 'SR' bylaws, rules, regulations and guides are based upon assumed *TRUTH* that have their roots in *ANALYTICAL* evaluation and real or *EMPIRICAL* evidence presented by countless other individuals.
- 10. 'SR' Technology does not claim to be 'RIGHT' but is built upon a desire and search to find 'RIGHT'.
- 11. All ideas, *FACTS* and *OPINIONS* that have been researched have been extensively evaluated and *ANALYZED* to determine if it can be classed as a *FACT* or *TRUTH* as opposed to an *OPINION*.
- 12. *OPINIONS* are acknowledged as such but *IGNORED* from a view of having an influence on the development of the 'SR' Technology.
- 13. An 'SR' entity is one hundred percent owned by the society at large. No *INDIVIDUAL* ownership of any of the assets of the 'SR' entity is allowed or possible.
- 14. Within the 'SR' Technology, forgiveness is only *FORGIVENESS* if it is built upon the concept that the aim is to *REHABILITATE* the individual to be forgiven, to their demonstrated *BEINGNESS* that their counter survival activity could never be repeated again.

### 'SR' bylaws, rules, regulations and directives:

The purpose of this section is to give a vestigial overview pertinent to a summary as opposed to the extensive body of work detailing the full *INTENT* of these directives. This text is not to represent the actual bylaws of the 'SR' Technology, but the plain text content to be used to build the bylaws, rules, regulations etc..

# N. The 'SR' entity:

- 1. The 'SR' entity is only applicable to a <u>newly</u> created entity supplying goods and/or services to the society:
- 2. It is not envisioned that any existing entity could change from current operation to 'SR' operation.
- 3. Any individual wishing to found an 'SR' entity may apply for *AUTHORIZATION* to be identified as 'SR' certified.
- 4. Qualification for 'SR' *AUTHORIZATION* are the complete demonstrated *UNDERSTANDING*, and commitment to them, of all of the 'SR' bylaws, rules and acts.
- 5. *AUTHORIZATION* can only be granted by the 'SR' watchdog committee and may be withdrawn as outlined in the bylaws.
- 6. Funding for the founding of the 'SR' entity will be supplied by existing social funds and/or the 'SR' *EXPANSION FUND*.
- 7. No private funds facilitating part ownership or return of investment are permitted for any reason.
- 8. Every individual in an 'SR' entity from the lowest to the highest position is an employee of the 'SR' entity' remunerated by a salary commensurate with their *RESPONSIBILITY* and or knowledge or effort required to perform that specific function.

- 9. Every individual employed by an 'SR' entity has been processed for *UNDERSTANDING* of their job function and duties before hiring as well as all bylaws pertinent to their position.
- 10. Every employee of the 'SR' organization is granted the distinction of being an 'SR' *DEFAULT CITIZEN*.
- 11. A *DEFAULT CITIZEN*, just like the 'SR' organization has an 'SR' statistic created and maintained by the methods detailed in the bylaws.

# **O.** The 'SR' entity organization:

- 1. Every employee who has a superior and/or subordinate has two communication channels in a purely vertical structure
- One: Monitor and discover what their subordinates require to enhance their performance and pass the appropriate request to their superior. Two: pass on to their subordinates the data, tools and information received from their superior.
- 3. The *ETHICS* officer's *RESPONSIBILITIES* are to assist in any issue that has been deemed to be unsolvable between any individual and their subordinate or superior.
- 4. The *ETHICS* officer also bears the *RESPONSIBILITY* to ensure that all applicable bylaws and *RESPONSIBILITIES* are adhered to by all.
- 5. Furthermore any discrepancy that can not be resolved internally and needs to be presented to the Watchdog committee of which that entity is attached to, is a further *RESPONSIBILITY* of the *ETHICS* officer/office.
- P. 'SR' TRANSPARENCY:
- 1. *TRANSPARENCY* is one of the most important practice in the makeup of the 'SR' Technology.
- 2. Every 'SR' entity is bound to have all of its records and dealings published on the Internet.
- 3. Every 'SR' entity regardless of providing a service or product to society has one common interface for their financial operation. The beginning of the chain starts from what may be called the "*INTERNATIONAL HOME PAGE (IHP*) of 'SR' " and from there divides down to the individual entity.
- 4. The interface for the chain from the *IHP* down to the individual entity has the same look and feel for every 'SR' entity.
- 5. The individual entity's financial breakdown is identical for all entities regardless of product type or service provided.
- 6. Non applicable financial entries for that specific entity are grayed out, but are still listed in order to facilitate a common interface.
- 7. It is illegal for any 'SR' entity to maintain any data or information that is not published on the internet.
- 8. Any hard copy or local data must be a duplicate of what is contained on the internet.
- 9. Cookies are used to enable any user to immediately go to the entity, by country, area, product type, organization etc. to enable to go to their individual area of interest without having to step through the tree from *IHP* to their area of interest.
- 10. The most important data as specified in the bylaws must be published on the web within no more than three days after it has occurred.

11. By the process described in the bylaws every *INDIVIDUAL* who is employed by an 'SR' entity has an obligation to monitor the data pertinent to their area of *RESPONSIBILITY* and report, by process described in the bylaws, any perceived discrepancy so perceived to the *ETHICS* officer or office.

# Q. 'SR' entity association:

- 1. Every 'SR' entity providing something for the society is categorized by this service and belongs to that group regardless of their geographical location.
- 2. Any new entity *AUTHORIZED* to create an 'SR' entity will be assigned a group that they belong to by the "Watchdog Committee" in that discipline.
- 3. Within 'SR' there is no such thing as us and them, there is only us, which collectively is humanity
- 4. Any new discovery, invention, procedure or the like is immediately available to anyone since it is immediately published on the internet. It is available to anyone, 'SR' or not.
- 5. Advertising as it is known outside of 'SR' is prohibited by any 'SR' entity since it is not a benefit to the society locally or globally.
- 6. Advertising, as it is known outside of 'SR', is converted to product information within 'SR' as opposed to tempting an individual to buy or make them believe that they need that product or service for their happiness.
- 7. The only product information is to inform society of the existence of a product or service including product specifications, reliability statistics and like items.
- 8. It is illegal to use resources to pay things like radio, television, magazines, flyers or similar mechanisms, used to day, for advertising.
- 9. All product information will be handled by the 'SR' website presence, informing the public what is available and how to get it when <u>they choose</u> to desire it.

# **R. 'SR' Sustainability:**

- 1. Within 'SR', *SUSTAINABLE* has nothing to do with *SUSTAINABILITY* of any single individual, organization, group, specific society etc.
- 2. *SUSTAINABILITY* refers to the best concept of *INFINITE*; survival and *CONTENTMENT* of humanity, all life on the planet and the persistent availability of the resources provided by the planet for the continuation of that life.
- 3. Within the current state of the planet, literally no measure of what is and is not *SUSTAINABLE* on any front, except sustainable "*INDIVIDUAL* 'Economic' Dominance" is available.
- 4. Although no specific data is available, it is believed that as through the existence of 'SR' entities, as data becomes available the 'SR' Technology is able to incorporate it.
- 5. Certainly the 'SR' Technology has the capacity to make changes without loosing its *INTENT* of "*SUSTAINABLE* Social *ECONOMIC* Well Being" so long as the full *INTENT* of the 'SR' Technology is understood, implemented and defended.

# S. Summary:

1. The above is a very brief overview of some of the text describing the concept behind creating the legal *DOCUMENTATION* to be developed for operation of an 'SR' entity.

- 2. It will be up to the lawyers and accountants to develop these concepts into the legal texts, acts and regulations that will direct the creation of the first and all 'SR' *AUTHORIZED* entities.
- 3. Although an individuals awareness of the content and *INTENT* of the 'SR' technology is considered to be a very beneficial outcome, it by itself can not create an 'SR' entity.
- 4. However, the more *INDIVIDUALS* there are who have this awareness, the more rapid may be the expansion of the 'SR' Technology.
